SUPPLEMENT TO MOTION TO COMPEL RAPOWER-3 TO RESPOND TO PLAINTIFF'S FIRST INTERROGATORIES

On June 21, 2016, the United States filed its motion to compel RaPower-3 to respond to

the United States' first interrogatories. (Doc. No. 53). Within hours, RaPower-3 provided

responses, (Doc. No. 54; Exhibit B), but RaPower-3's responses are still deficient for the reasons

stated below:

- 1. RaPower-3 did not sign the responses.
- RaPower-3's responses do not correspond to the interrogatories propounded to it. The United States propounded 22 interrogatories to RaPower-3. (Doc. No. 53-1.). RaPower-3 provided 18 responses. RaPower-3's responses appear to be a nearcopy of the interrogatory responses of its co-defendants, International Automated Systems (IAS), and LTB1, LLC despite the United States issuing different and/or additional interrogatories to RaPower-3.
- 3. RaPower-3's responses are deficient for the same reasons that the United States noted in its letter of June 2, 2016 to Mr. Justin Heideman, regarding RaPower-3's co-defendants', IAS, LTB1, and Neldon Johnson. (Exhibit C.) Several of RaPower-3's responses are incomplete, non-responsive and improperly invoke the standard protective order.
- Furthermore, RaPower-3's responses contain objections; any objections RaPower-3 may have had are waived because RaPower-3 failed to timely object. *See Kelatron v. Marlyn Nutraceuticals*, 2013 WL 4498722, at *3 (D. Utah 2013).

Accordingly, the United States requests that the Court:

- 1. Order RaPower-3 to sign the responses it provided on June 21, 2016 within 7 days.
- Find that RaPower-3 has waived any objections to the United States' interrogatories and prohibit RaPower-3 from raising any objections in its responses to the United States' interrogatories;
- Order RaPower-3 to fully answer the United States' first interrogatories in accordance with Fed. R. Civ. P. 33 within 7 days.
