RECEIVER'S SPECIAL REPORT ON STATUS OF LITIGATION

R. Wayne Klein, the Court-Appointed Receiver (the "Receiver") of RaPower-3, LLC ("RaPower"), its subsidiaries and affiliates ("Receivership Entities"), and the assets of Neldon Johnson and R. Gregory Shepard, hereby submits this Special Report on Status of Litigation ("Report"), as of February 25, 2021.

I. <u>OVERVIEW</u>

The Receivership Estate was created on October 31, 2018 with entry of the Court's *Receivership Order* ("Order"), ¹ which, among other things, appointed the Receiver and continued a previously-entered asset freeze. ² A May 3, 2019 order expanded the Receivership Estate to include 13 additional affiliated entities ("Affiliated Entities"). ³

On May 24, 2019, the Court granted the Receiver's motion to commence legal proceedings. Since that time, the Receiver has filed over a hundred lawsuits against family members, insiders, law firms, credit card issuers, commission recipients, and others. In addition, the Receiver has made demand on others for returns of amounts improperly paid out by Receivership Entities and has settled approximately 20 of these cases without the necessity of initiating litigation.

This Report summarizes the progress to date of the litigation and settlements.

II. SETTLEMENTS

A. <u>Approved Settlements</u>. The Receiver has filed eight motions for approval of settlement agreements, all eight of which have been approved. As settlement agreements are approved and a pattern of payments is established, the Receiver dismisses the lawsuits underlying those settlements. The approved settlements (which are not in default) involve the persons listed in the table below:

- B. <u>Delinquent Settlements</u>. The defendants who are delinquent in their obligations under their settlement agreements are:
 - a. <u>Abdullah, Fareed</u>. He has made no payments. The settlement was reached before any lawsuit was filed. The Receiver is evaluating whether to initiate litigation;
 - b. <u>Ayres, Evan</u>. He has made no payments. The settlement was reached before any lawsuit was filed. The Receiver has filed a lawsuit against Ayres, Case No. 2:21-cv-00110-DN;
 - c. <u>Griffin Painting</u>. Case No. 2:19-cv-00844-DN-PK (case dismissed). \$15,750.00 of the \$19,688.17 settlement amount has been paid. Defendant is beyond the

agreement deadline, but has requested additional time due to financial losses in his business due to COVID;

- d. <u>Luke, Shane</u>. Case No. 2:19-cv-00688-DN-PK. A partial payment was made. An extension to February 15, 2021 was granted for the remainder. Shane Luke failed to make this payment.
- e. <u>Bowers, Steven</u>. Case No. 2:19-cv-00530-DN-PK. Bowers has failed to make the settlement payment. The Receiver will initiate an action against Bowers for breach of the settlement agreement.

III. SUMMARY JUDGMENT MOTIONS

The Receiver has filed summary judgment motions in the cases listed in the two tables below. Most, but not all, involve payments of commissions for sales of solar lenses. On February 25 and 26, 2021, the Court indicated it was granting summary judgment in the cases in the table below:
