RECEIVER'S EIGHTH SPECIAL REPORT ON STATUS OF SETTLEMENTS AND LITIGATION

R. Wayne Klein, the Court-Appointed Receiver (the "Receiver") of RaPower-3, LLC ("RaPower"), its subsidiaries and affiliates ("Receivership Entities"), and the assets of Neldon Johnson and R. Gregory Shepard, hereby submits this Eighth Special Report on Status of Settlements and Litigation ("Report"), from August 16, 2022 to November 16, 2022.

#### I. OVERVIEW

The Receivership Estate was created on October 31, 2018 with entry of the Court's Receivership Order ("Order"). Thirteen affiliated entities were added on May 3, 2019. Also

in May 2019, the Court authorized the Receiver to commence legal proceedings.<sup>3</sup> This Report summarizes the progress to date of settlements and ongoing litigation.

The most significant changes since the prior Litigation Status Report are:

- 1. One delinquent defendant paid the full amount of his settlement;
- 2. Garnishment hearings were concluded in the cases of the three judgment defendants who opposed garnishment orders granted to the Receiver;
- 3. One of the garnishment cases resulted in a settlement agreement and the condition precedent to another settlement occurred, making that settlement agreement final (the Receiver has moved for approval of both of these settlements), which will reduce the number of pending, unresolved cases to seven;
- 4. Three pending lawsuits have been reassigned back to Judge Nuffer; and
- Final trial preparations are in process for the January combined trial against Christopher Taylor and Curtis Snow.

#### II. <u>SETTLEMENTS</u>

A. <u>Approved Settlements</u>. The Receiver has filed 16 motions for approval of settlement agreements, 15 of which have been approved. The status of these settlements are:
