Objection to United States' Proposed Order on Motion to Compel Deposition Testimony of

Kenneth Birrell. The reasons for the objection are set forth below:

1. On April 19, 2017, Counsel for Plaintiff and Defendants met and conferred telephonically

to discuss the form of the Proposed Order.

- The parties were unable to come to an agreement regarding certain language in the Proposed Order.
- 3. On April 20, 2017, Plaintiff submitted its Proposed Order.
- 4. The Proposed Order contains the following statement, made without any qualifications or clarifiers: "Defendants have waived attorney-client privilege with respect to all documents produced by Mr. Birrell to the United States."
- 5. The Plaintiff's characterization of the Court's order is overbroad.
- 6. The Court's actual statement was more limited in scope, and explained that the waiver of privilege is limited to the information contained on the face of the document itself. This naturally *does not operate as a waiver* of any privileged communications that may have been had regarding the subject matter of the documents.
- The Court also explained that it would be willing to consider a motion to "claw back" inadvertently disclosed privileged information.
- 8. Given the history of this case, it is important that the limitations on the Court's Order are included in the Order, in order to avoid unnecessary future disputes.
- 9. As such, Defendants have submitted a Proposed Order, attached hereto as Exhibit 1.
- 10. For the reasons set forth herein, this Court should deny Plaintiff's Proposed Order and instead grant Defendants' Proposed Order.
