Upon consideration of the United States' motion to take certain discovery out of time, IT IS HEREBY ORDERED THAT the motion is GRANTED as follows:

- The United States shall depose Defendants LTB1, LLC, International Automated Systems, Inc., RaPower-3, LLC, and Neldon Johnson during the week of June 26, 2017, on a schedule set by counsel for the United States.
- 2. If the Court grants the United States' motions to compel regarding Kenneth Birrell and/or Todd Anderson, the United States shall take any ordered deposition on or before October 6, 2017, at a date and time set by counsel for the United States upon reasonable consultation with all counsel.
- 3. If the Court grants the United States' motion to compel regarding Cody Buck, Ken Oveson, and/or David Mantyla, the United States shall take any ordered deposition on or before October 6, 2017, at a date and time set by counsel for the United States upon reasonable consultation with all counsel, and:
 - a. The United States shall take the deposition of Richard Jameson on or before
 October 6, 2017, at a date and time set by counsel for the United States upon
 reasonable consultation with all counsel.
 - b. If permissible under 26 U.S.C. § 6103(h)(4), the United States shall produce certain tax returns prepared by Jameson for Defendants' customers no later than two weeks after taking Jameson's deposition.
- 4. If the District Court for the Northern District of Texas grants the United States' motion to compel the deposition of John Howell:

- a. The United States shall take Howell's deposition on or before October 6,
 2017, at a date and time set by counsel for the United States upon reasonable consultation with all counsel.
- b. If permissible under 26 U.S.C. § 6103(h)(4), the United States shall produce certain tax returns prepared by Howell for Defendants' customers no later than two weeks after taking Howell's deposition.
