I spoke with you a little over a year ago when a client of mine was preparing to purchase solar energy equipment with IASU, regarding the tax implications.

My client did purchase some units in Dec of 2009. Recently she received a check for \$7500.00 from RAPOWER-3 LLC. This is the first we have heard anything about her units. I wrote to IASU in Sept 2010 asking for information about her units and an update as to what is going on, and never heard back from them.

This is disturbing to my client as well as myself.

The check states it is for the 3rd quarter power purchase. What about the 1st and 2nd quarters? Also, can you provide a schedule or statement as to how the power purchase is determined? Will we receive quarterly distribution going forward?

Any information we could obtain would be most appreciated.
