

Everyone:

That's a three year combined state and federal tax return total of \$61,130. What M&C failed to mention in the above letters is that the equipment purchased will pay them back \$300,000+ over the next 35 years, AND that the RaPower3 Bonuses they have qualified for amount to \$522,000; AND that due to following the program properly, they quite possibly (depending on their income) be 'tax free' Thru 2016.
