## NEED A TAX CREDIT?

Are you tired of sending your money to Washington for Nancy Pelosi and Harry Reid? Want to control where your tax dollars go? We have discovered a way to do just that!

The AARA (American Recovery and Reinstatement Act), passed last year by the federal government, provides tax credit to those who purchase items in the “Green Energy” of the future. Bigger, Faster, Stronger (BFS), the number one weight-training equipment provider in the county, has invented a program that allows you to take advantage of these tax credits and help Meadowbrook Park via - the RAPower3 systems program.

Here is how the program works: Individuals purchase RAPower3 alternative energy systems according to how much income tax they are currently paying. They would file an amended W-4 to reduce the amount of pay that is being withheld and use that money to purchase power units. In essence, you are not spending money, you are re-allocating income tax money to the energy program. Meadowbrook Park receives five percent of the purchase and the residual income. You receive a 30% tax credit, \$900 per system you buy. You also receive a 60% depreciation incentive in the first year = \$1530. The \$900 credit + \$1530 depreciation incentive = 15% - 20% return on money you never see (income tax)- all in the first year! This program is guaranteed by government legislation and repeatable each year through 2016.

The Friends of Meadowbrook would like to use this program to build the endowment for Meadowbrook Park through the “Paul R. Glick Memorial Fund” administered by the Tiffin Charitable Trust. All commissions for the program are deposited in the Glick Fund. Our goal would be to build the endowment to a total of 2 million dollars by the end of the four-year tax credit window.

Listen to Mr. Sheppard give you the overview of the program and then click on Opportunities. Here you click on the {Fundraising} tab. This will give you an overview of the total program. If you decide to join us, click on the {Purchase/Join tab} and then click the {next} button. This takes you to the Sponsor page. Here you type in [meadowbrookpark](http://meadowbrookpark) (all one word in lower case) as the Sponsor. Click {find sponsor}, this will take you to the application page and you can enroll to purchase your systems.

If you need someone to help you with the details and provide you with information regarding the program please contact me. I would be happy to answer any questions you might have and guide you through the process. We need to get 200 people to purchase at least one system each year for the next four years to reach our goal of a 2 million dollar endowment.
