1. We know this whole IRS thing has been stressful. We are sorry for this. We believe our technology will soon be ready and be in full production. We also believe we will prevail against the IRS in court.

However, if you would like to part company, we will refund your money and you can pay the IRS and move in a different direction. You can most likely get the IRS to drop the penalties. But, if you decide on the refund, then you would give up all bonuses and rental fees associated with those solar lenses. This offer is good until Feb. 15th 2015.

When that happens that shoots down the IRS argument that the only reason that RaPower3 members got involved in the first place was ONLY for the tax benefits. Thus, it was a tax avoidance scheme or a Ponzi scheme. This would also be a devastating blow to the IRS case.

9. With all the above happening, the press and media will be doing stories. Polititions will become involved and the IAUS stock price should move upward (perhaps dramatically). All this will be extremely bad for the IRS; especially if the press gets wind of the IRS abuses against us.
