Dear Mr. Nelson:

Thank you for the explanations and documents provided in and with your letter dated December 17, 2018. I am reviewing the information you provided and may have additional questions. For now, I wish to follow up on three items. I am required to provide a report to the Court by the end of the month on a number of items and want to get clarification from you for matters that will be addressed in my report.

1. Payments to Nelson Snuffer. Pursuant to ¶ 9 of the Receivership Order, all prior directors, officers, managers, employees, attorneys, and other agents of RaPower-3 and IAS were dismissed effective October 31, 2018. Under ¶ 3, I have exclusive authority to act on behalf of RaPower-3 and IAS. In light of that, I renew—and narrow—my request for information about all payments made to Nelson Snuffer by RaPower-3 and/or IAS. I want to know what payments RaPower-3 or IAS made to Nelson Snuffer. If you do not have this information for all prior time periods, I am requesting the information that you do have. If you continue to assert that I am not entitled to this information—as the sole authorized representative of RaPower-3 and IAS—please so indicate in writing.
2. Engagement Agreements. I am requesting copies of all engagement agreements that were signed on behalf of RaPower-3 or IAS. If you continue to assert that I am not entitled to agreements to which RaPower-3 or IAS were parties, please so indicate in writing.
3. N.P. Johnson Family Limited Partnership. If I understand information in your letter correctly, the following are owners of the N.P. Johnson Family Limited Partnership:
  - a. 15% is owned by the LaGrand T. Johnson Family Trust;
  - b. 15% is owned by the Randale P. Johnson Family Trust;
  - c. 20% is owned by Roger Hamblin, which was purchased from Neldon Johnson;
  - d. 20% is owned by DCL-16A (which was sold by Neldon Johnson to Roger Hamblin).

Please identify the owner(s) of the remaining 30% of the entity.

Page 5 of your letter contained three references to “NP Johnson Family LPS.” Is this a reference to the N.P. Johnson Family Limited Partnership or is there another entity that is intended to be referenced by the NP Johnson Family LPS?

In light of my deadline to file a report by the end of the month—and the limited nature of this inquiry—please respond by December 26, 2018.
