**ORDER TAKING SHOW-CAUSE
MOTIONS UNDER ADVISEMENT**

Plaintiff United States of America filed a motion¹ for an order to show cause why R. Gregory Shepard, Neldon Johnson, Glenda Johnson, LaGrand Johnson, and Randale Johnson should not be held in civil contempt for failing to comply with the receivership order (the “Receivership Order”).² Similarly, R. Wayne Klein, the court-appointed receiver, (“Receiver”) filed a motion³ for an order to show cause why Pacific Stock Transfer Co. (“PSTC”) should not be held in civil contempt for failing to comply with the Receivership Order. To date, no response has been filed to either of these motions (collectively, the “OSC Motions”).⁴ Therefore, for good cause appearing,

IT IS HEREBY ORDERED that:

1. The OSC Motions⁴ are taken under advisement.

2. The United States must cause a copy of its OSC Motion⁵ and this Order to be served on Glenda Johnson, LaGrand Johnson, and Randale Johnson (collectively, the “Johnsons”) by no later than Friday, March 15, 2019.⁶ This service may be effectuated, at the United States’ option, by personal service or by posting a copy of this Order at the Johnsons’ residence *and* also mailing a copy of the motion⁵ and this Order to the Johnsons.


3. The Receiver must cause a copy of its OSC Motion⁷ and this Order to be served on PSTC by no later than Friday, March 15, 2019.

4. Any response to the OSC Motions must be filed by no later than Friday, March 29, 2019, and any reply must be filed by no later than Friday, April 12, 2019.

5. An evidentiary hearing on the OSC Motions will be held Friday, April 26, 2019, at 9:30 a.m., in courtroom 7.300.
