**ORDER GRANTING MOTION TO
WITHDRAW AS COUNSEL**

IT IS HEREBY ORDERED that Nelson Snuffer Dahle & Poulsen P.C.'s motion to withdraw as counsel ("Motion")¹ is GRANTED. Denver C. Snuffer Jr., Steven R. Paul, Daniel B. Garriott, Joshua D. Egan, together with the law firm of Nelson Snuffer Dhale & Poulsen P.C., may withdraw, and are hereby removed, as counsel for Defendants RaPower-3 LLC, International Automated Systems Inc., LTB1 LLC, R. Gregory Shepard, and Neldon Johnson ("Clients").

IT IS FURTHER HEREBY ORDERED that:

1. Clients or new counsel for Clients must file a notice of appearance or a notice of substitution of counsel within *14 days* after entry of this Order.² In accordance with [DUCivR 83-1.3\(c\)](#), no corporation, association, partnership, or other artificial entity may appear pro se, but must be represented by an attorney who is admitted to practice in this court. A party who fails to file a notice of appearance or notice of substitution of counsel may be subject to


sanction under Fed. R. Civ. P. 16(f)(1), including but not limited to dismissal or default judgment.

2. This action shall be stayed until *14 days* after entry of this Order.³ However, neither this stay nor anything else in this Order shall affect the dates or deadlines set forth in the Order Taking Show-Cause Motions Under Advisement⁴ or in the Memorandum Decision and Order Denying the Johnsons' Rule 26(c) Motions.⁵ All litigation dates set forth in those orders and in the controlling scheduling order remain in effect.

The clerk is directed to serve a copy of this Order on Clients at the addresses set forth in the Motion.⁶
