On January 29, 2019, the United States filed its motion for order to show cause why Neldon Johnson, R. Gregory Shepard, Glenda Johnson, LaGrand Johnson, and Randale Johnson should not be held in civil contempt of court for violating the Corrected Receivership Order.¹ This Court took the motion under advisement, ordered briefing on the motion, and set an evidentiary hearing on the motion.² The Court also ordered that the United States cause a copy of its motion and the order establishing deadlines to be served on Glenda Johnson, LaGrand Johnson, and Randale Johnson (collectively, “the Johnsons”) no later than March 15, 2019.³ The Court allowed service to be effected by “posting a copy of this Order at the Johnsons’ residence and also mailing a copy of the motion and this Order to the Johnsons.”⁴

Please take notice that the United States has effected service, as shown by the attached documents: a Certificate of Service regarding mailing the motion for order to show cause and the order, and Affidavits of Service regarding the posting of the order at the Johnsons’ addresses.
