2. 4. No other bidder appeared at the auction, so the Receiver awarded the property to the stalking horse bidder for the bid of \$8,500.

5. The sale of the Real Property to the stalking horse bidder (Erick Lopez) closed on August 28, 2019. The following is a summary of the results of this sale.
