4. I was not a grantor or settlor of the Trust.

5. I am not a trustee of the Trust.

6. I do not have powers or amendment or revocation over the Trust. At best, I am a

contingent beneficiary of the Trust in that I believe I can remain living on the Property in

the event of my wife's death, after which the Property would be distributed to our children.

7. Between 2010 and 2016 Shepard Global lost approximately \$100,000 in investments in
