- 4. The United States will not be filing a reply, as it addressed all necessary matters in its opening brief. For the same reason, the United States does not believe there is a need for an evidentiary hearing; the Receiver has authorized counsel for the United States to report that he concurs.

Therefore, the Motion is ripe for the Court's decision. The United States requests that the Court grant the Motion and order the requested relief.
