Pursuant to the Court's Order re Affidavit of Non-Compliance against Glenda Johnson, dated May 5, 2020 (the "Order"), <sup>1</sup> if Glenda Johnson failed to dismiss the West Wings Lawsuit with prejudice within one day of the entry of the Order or failed to release the three liens on properties in Millard County, Utah; Payson, Utah; and Howard County, Texas within three days

of the entry of the Order, a bench warrant would be issued for her arrest.<sup>2</sup>

On May 5, 2020, Glenda Johnson filed a Motion to Dismiss the West Wings Lawsuit with Prejudice.<sup>3</sup> Although the West Wings Lawsuit has not been formally dismissed yet, the Receiver believes that so long as Glenda Johnson follows through with the Motion to Dismiss with Prejudice, she has complied with the Order as to the West Wings Lawsuit.

The Receiver, however, has received no information indicating that the liens on properties in Millard County, Payson, or Howard County have been released. In fact, the Receiver's investigation shows that the liens have not been released.<sup>4</sup>

The time for compliance has passed and Glenda Johnson has failed to release the liens as required under the Order.
