Pursuant to 28 U.S.C. § 1746, I hereby declare as follows:

1. My name is Roger Paul Hamblin, I make this declaration under oath and based on my personal knowledge. If called upon to testify as to the matters stated herein, I would testify consistent herewith.
2. I was interested in and monitored the IRS vs. Preston Olsen trail in the tax court in January, 2020.
3. When the IRS conceded that the Johnson Fresnel solar lenses were solar energy property, I was enthusiastic that RaPower could change the final judgment granted to the IRS in the Federal Court case (USDC Case No. 2:15-cv-00828) and wanted to preserve any interest in the companies and their assets that I could.
4. I called Glenda Johnson and said I wanted to buy any right, title or interest she had in the businesses and their assets.

5. She told me she had already sold to Preston Olsen in November, 2019. I told her I was still interested if she could talk to Preston Olsen, I would buy his interest.
6. On or about February 29, 2020, I met with Glenda Johnson in Payson, Utah, and bought Preston Olsen's interest in Anstram Energy LLC. See attached copy of Transfer of Membership Interests, which bears my signature.
7. Later, Glenda Johnson asked me to release the mechanics' liens on the real properties included in the purchase of Anstram Energy, LLC. I declined.
8. I received an email from Steven Paul asking me to release the liens. I declined.
9. I have no present intention to release the mechanics' liens on behalf of Anstram Energy.
10. Glenda Johnson has no authority or ownership of Anstram Energy LLC.
