

Comes now, Roger Hamblin and stipulates to a finding by the Court that he acted in contempt of Court as a result of his conduct in assisting Glenda Johnson in asserting liens against Receivership Property after the Court had ruled those real properties were under the exclusive control of the Receiver. Hamblin further stipulates to the Court entering as findings the allegations relating to Hamblin contained in the Receiver’s motion for order to show cause. Hamblin states, in mitigation, that he was manipulated to believe he had a right to assert a prior

claim that he felt he possessed. He further states that he had no intent to violate a duty or obligation he had to the Court, the Receiver, or the Receivership Estate.

Hamblin also stipulates to the Court entering an order requiring him to pay \$7,500.00 to the Receivership Estate as a contribution towards the costs and fees incurred by the Receiver and his counsel in investigating the liens, deposing Hamblin, and bringing the motion for an order to show cause. Hamblin acknowledges that while the Receiver has agreed to accept \$7,500.00 from Hamblin as Hamblin's contribution towards these fees and costs, this stipulation and agreement does not preclude other persons who are subject to the motion for an order to show cause from seeking additional contribution from Hamblin in the event these other persons are required to reimburse higher amounts to the Receiver.
