R. Wayne Klein, the court-appointed receiver ("Receiver") filed a stipulation as to his recommendation for living expenses allowance for R. Gregory Shepard ("Stipulation").¹ Based upon the Stipulation and for good cause appearing,

IT IS HEREBY ORDERED that:

1. The monthly living allowance amount for R. Gregory Shepard ("Shepard") and his wife Diana C. Shepard is \$4,528.00. After accounting for the approximately \$2,700.00 Shepard and his wife receive in Social Security payments, a monthly shortfall of approximately \$1,830 exists.

 The Receiver may direct Bigger, Stronger, Faster to send the monthly payment of \$1,000 directly to Shepard.

3. The Receiver is authorized to pay Shepard \$830 monthly from the Receivership operating account.

4. Shepard may retain amounts he earns from substitute teaching but must respond accurately and promptly to inquiries from the Receiver regarding the amounts Shepard earns.

5. Annuity payments from Allianz that are currently being paid to the Receiver shall continue to be paid to and retained by the Receiver.

6. Shepard shall ensure that IAS stock that he transferred to Diana Shepard and Matt Shepard are not sold or transferred to others and shall cooperate with the Receiver in delivering those shares to the Receiver.
