1. I am an Assistant Chief for the Tax Division's Civil Trial Section - Central Region, at the United States Department of Justice, and I am a trial attorney of record assigned responsibility for this case.

2. I have reviewed the United States' records recording both attorney's fees and costs related to bringing the Motion for Order to Show Cause Why Neldon Johnson, R. Gregory Shepard, Glenda Johnson, LaGrand Johnson, and Randale Johnson Should Not Be Held in Civil Contempt of Court and enforcing the Court's Corrected Receivership Order.

3. Attached as Plaintiff's Exhibit 957 is a true and correct copy of an Excel sheet I created to summarize those records. The amounts identified for each line item are correct. Receipts for costs greater than \$100 are also attached to Pl. Ex. 957.

4. As shown on Pl. Ex. 957 at 3-4, the United States has incurred at least \$22,044.12 in attorneys' fees and \$3,102.73 in costs, for a total of \$25,146.85 in fees and costs, to bring its motion for order to show cause and to enforce the Corrected Receivership Order.
