At a hearing on February 25, 2020, the Court made findings of contempt regarding actions of Neldon Johnson, Glenda Johnson, and others. Among the findings made on February 25, 2020 was a determination that all vehicles identified by the Receiver in Exhibit 2162 are Receivership Property and belong to the Receivership Estate.<sup>1</sup> The Court directed the Receiver to submit a proposed order regarding the delivery of the vehicles to the Receiver.<sup>2</sup> The proposed
