Ms. Canady:

I have not heard from Pacific Stock Transfer since our phone call on July 1st. I am calling to follow up on the following matters:

- As I mentioned on the phone, although the documents produced on June 24, 2019 represented a good deal of new information not previously produced to the Receiver. The Receiver has requested Pacific Stock Transfer turn over all paper and electronic information of, or relating to, IAS, RaPower, LTB1, Neldon Johnson or Shepard including books, records, documents, accounts, stock certificates, intellectual property records, evidence of intellectual property rights, computer and electronic records, and all other instruments and papers.
- On our phone call I also asked for any information regarding the price per share of the transactions listed on the document titled *IAUS – TransJrl* (attached).
- During our conversation, you indicated that you believed Pacific Stock Transfer has produced all documents and information in its possession or control related to IAS. I asked for a declaration, under oath, affirming that Pacific Stock Transfer has in fact produced everything to the Receiver and therefore is in compliance with the Corrected Receivership Order.

As I mentioned above, we have not received any communication or the requested declaration from Pacific Stock Transfer. As you are aware, the Court has entered a coercive fine against Pacific Stock Transfer of \$2,000 for every day past June 10, 2019 that you are not in full compliance with the court's orders. Additionally, the Court has awarded the Receiver his fees in the amount of \$6,160.40 to be paid to the Receiver no later than August 1, 2019 (attached).

Pacific Stock Transfer has not purged its contempt under the civil contempt order. Pacific Stock can purge its contempt by: 1) providing all the information required under the Court's orders, and 2) executing and delivering a declaration, under oath, affirming that Pacific Stock Transfer has in fact produced everything to the Receiver and therefore is in compliance with the Corrected Receivership Order.

If Pacific Stock Transfer continues to fail to comply with the Court's orders, the Receiver will seek additional remedies from the Court.

Ms. Canady:

PSTC is currently in civil contempt of court for failing to comply with a valid court order. The Civil Contempt Order (attached) is clear that if PSTC does not fully comply with the Corrected Receivership Order by June 10, 2019, a \$2,000 per day fine will be imposed. Today is June 24, 2019, 14 days after the June 10th deadline. The Civil Contempt Order also entitles the Receiver to reasonable attorneys' fees and cost related to the motion for order to show cause the Receiver filed against PSTC. PSTC has been unresponsive despite many opportunities to respond and provide documents including:

- The Receiver received no response to his January 18, 2019 letter explaining "I am the only person authorized to act for IAS. That means any information that IAS could seek from PST must be delivered to me."
- PSTC filed no response to the Receiver's motion for order to show cause which was personally served on PSTC on March 8, 2019 along with the Court's order taking the motion under advisement.
- PSTC failed to appear at the April 26, 2019 hearing on the Receiver's motion for order to show cause where the court found that PSTC was in contempt of court for violating the Corrected Receivership Order.
- PSTC failed to respond to the proposed order which was personally served upon PSTC on May 8, 2019.
- PSTC failed to respond to the Receiver's motion for attorneys' fees and costs which was personally served upon PSTC twice.
- PSTC failed to respond or comply to the Civil Contempt Order which was personally served by the US Marshall service in early June.

You are correct that this is an urgent matter. PSTC's disregard for court orders and requests from a properly appointed receiver has delayed the Receiver's investigation considerably. We are happy to set up a call to discuss this matter further whenever you would like. The Receiver will review the documents provided in your email this morning and let you know whether more documents are required under the Corrected Receivership Order.
