Pursuant to Rule 26(f) of the *Federal Rules of Civil Procedure*, Plaintiff R. Wayne Klein as receiver (“Receiver”) and Defendant Glenda E. Johnson (“Glenda”), by and through their counsel, hereby submit the following report of their attorney planning meeting:

1. PRELIMINARY MATTERS:

a. This case arises as an ancillary action to Case No. 2:15-cv-00828. The Receiver has brought claims seeking avoidance of fraudulent transfers made by Receivership Entities to Glenda and asserting a claim for unjust enrichment.

c. Pursuant to Fed. R. Civ. P. 26(f), a meeting was held on 10/23/19 via email.
The following attended:

Jeffery A. Balls, counsel for the Receiver

d. The parties will exchange by 11/08/19 the initial disclosures required by Rule
26(a)(1).

e. Pursuant to Fed. R. Civ. P. 5(b)(2)(D), the parties agree to receive all items
required to be served under Fed. R. Civ. P. 5(a) by either (i) notice of electronic
filing, or (ii) email transmission. Such electronic service will constitute service
and notice of entry as required by those rules. Any right to service by USPS mail
is waived.

2. DISCOVERY PLAN: The parties jointly propose to the court the following discovery
plan:

a. Discovery is necessary on the following subjects: All claims and defenses pled
by the parties.

b. **Discovery Phases:** Discovery will not be conducted in phases.

c. **Discovery limitations:** The parties agree that the following limitations on written
discovery are reasonable and should apply to fact discovery:

- (1) Maximum interrogatories by any party to any party: 25
- (2) Maximum requests for production by any party to any party: 25
- (3) Maximum requests for admission under Rule 36(a)(1)(A) by any party to any party: 25

| (5) Maximum number of percipient witness depositions ¹ by any party: | 10 |

d. Discovery of electronically stored information should be handled as follows: At this time, the parties do not anticipate extensive electronic discovery will be necessary. Instead, electronic discovery will consist primarily of the collection, review, and production of certain email from a few custodians and certain accounting records. The parties will meet and confer within fourteen (14) days following the completion of their initial disclosures to consider an appropriate electronic discovery protocol.

e. The parties have agreed to an order regarding claims of privilege or protection as trial preparation material asserted after production, as follows: The inadvertent disclosure or production of any information or documents that is subject to an objection on the basis of attorney-client privilege or work-product protection, will not be deemed to waive a party's claim to its privileged or protected nature or estop that party or the privilege holder from designating the information or document as attorney-client privileged or subject to the work product doctrine at a later date.

Any party receiving such information or document shall return it upon request from the producing party. Upon receiving such a request as to specific information or documents, the receiving party shall return the information or documents to the producing party within five (5) business days, regardless of whether the receiving party agrees with the claim of privilege and/or work-product protection. Disclosure of the information or document by the other party prior to such

later designation shall not be deemed a violation of this agreement or any Court Order incorporating this agreement.

f. Last day to file written discovery: 02/27/20

g. Close of fact discovery: 03/27/20

3. AMENDMENT OF PLEADINGS AND ADDITION OF PARTIES:

a. The cutoff date for filing a motion to amend pleadings is: 01/27/20

b. The cutoff date for filing a motion to join additional parties is: 01/27/20

(NOTE: Establishing cutoff dates for filing motions does not relieve counsel from the requirements of Fed. R. Civ. P. 15(a)).

4. EXPERT REPORTS:

a. Deadline for Party bearing burden of proof to make initial expert disclosures under Rule 26(a)(2): 04/24/20

b. Deadline for Party not bearing burden of proof to make counter expert disclosures under Rule 26(a)(2): 05/22/20

c. Deadline for Party bearing burden of proof to make rebuttal expert disclosures under Rule 26(a)(2): 06/08/20

5. OTHER DEADLINES:

a. Expert Discovery cutoff: 06/19/20

b. Deadline for filing dispositive² or potentially dispositive motions: 07/27/20

c. Deadline for filing partial or complete motions to exclude expert testimony: 07/27/20

6. ADR/SETTLEMENT:

b. The parties will re-evaluate the case for settlement/ADR resolution on (*specify date*): 06/29/20
